#### **AUTHORIZED INSTALLATION PERSONNEL**

These kits are to be installed by factory authorized servicers or by personnel specifically trained for the installation. Installation of these kits by unauthorized personnel will void any existing warranty on the grill.

Improper installation, alteration, adjustment, service, or maintenance can cause property damage, injury, or death. Read these instructions thoroughly before installing the kits.

Inspection, testing, and repair of electrical components will expose personnel to the possibility of electric shock. The grill should be unplugged when servicing, except when operational tests are required. Do not attempt to install any parts from the certification kits unless all power to the grill has been disconnected.
